About the Cover: On January 20, 2000, Senator Jesse Helms, then Chairman of the U.S. Senate Foreign Relations Committee, made history by becoming the first legislator from any country to address the U.N. Security Council. His historic speech was prompted by the successful conclusion of negotiations that outlined the U.N. operations reforms that were required if the United States Congress was to restore U.N. funding. The reform, ultimately known has the Helms-Biden agreement (then U.S. Senator Joe Biden was a key figure in the reform) rocketed Senator Helms to international headlines. Reporters, accustomed to the softer speech of the diplomatic corps, were shocked at Senator Helms' frank and forceful demands. However, the results of Helms' speech could not be denied by critics and supporters alike. The U.N. later voted to accept the plans that Helms and Biden laid out - without a single change. An excerpt of his landmark address appears to the right. The photo was taken on that historic day.

## A CONSTITUTIONAL CALL TO ACTION

Over the last two years, as most Americans focused their attention on the state of the economy, the Obama administration has engaged in numerous activities, actively promoted by the State Department, that threaten our national sovereignty. Of course, these activities would have been effectively opposed by Senator Helms. As you may remember, Senator Helms had a rocky relationship with the State Department.

I recall a story told by a Helms staffer who, upon visiting the State Department while Senator Helms served as Chairman of the Foreign Relations Committee, noticed an 8x10 picture of Senator Helms sitting on the desk of an employee there. When the State Department employee was asked why he had a picture of Helms on his desk, he simply stated: "To

remind me that he's always watching."

Earlier this year, I had the honor to sit down with former U.N. Ambassador John Bolton. Ambassador Bolton shared with me his concern that the Obama administration was undermining our national sovereignty and utilizing willing partners known as NGO's (non-government organizations) to circumvent the will of Congress and the American people.

Did you know that Secretary of State Clinton recently told world leaders that she remained hopeful that the United States would join the International Criminal Court? And did you know that just a few weeks ago Associate Justice Ginsburg told an audience that she was hopeful the Supreme Court

would look to international law when deciding cases?



# JOHN BOLTON DELIVERS INAUGURAL HELMS LECTURE

"Defending National Sovereignty in the Age of Obama"

n Tuesday, March 30, the Jesse Helms Center and The Heritage Foundation's Margaret Thatcher Center for Freedom hosted the inaugural Jesse Helms Lecture Series speech at Heritage's headquarters in Washington, D.C. The lecture, which was broadcast internationally on C-SPAN, was given by former U.N. Ambassador John Bolton and was entitled "Protecting National Sovereignty in the Age of Obama."

In it, Bolton focused on the changes and compromises that have been made to America's foreign policy by President Obama since he took office.

The lecture commemorated the 10<sup>th</sup> anniversary of Senator Helms' historic speech to the U.N. Security Council. "Most Americans do not regard the United Nations as an end of itself - they see it as just one part of America's diplomatic arsenal," said Senator Helms in that historic U.N. address.

Bolton's presentation was both a warning and a commission for citizens to be more active and

aware of the monumental damage that will occur if America's national sovereignty continues to be compromised by international treaties and agreements that threaten the freedom of all Americans.

# Helms Fellows Program Unveiled


on January 20, 2010, the Helms Center celebrated the 10<sup>th</sup> anniversary of Senator Jesse Helms' historic speech to the U.N. Security Council. In commemoration of that groundbreaking event, we are pleased to announce the creation of the Jesse Helms Fellows initiative to build on Senator Helms' strong brand and legacy of principled leadership.

Our Helms Fellows, who will be affiliated with think tanks such as The Heritage Foundation and universities across the country, will analyze current public policy issues within Senator Helms' historical and philosophical framework of support for free enterprise, limited government and United Nations reform. The work of the Helms Fellows will be published by the think tanks or universities the fellow is affiliated with, as well as by the Jesse Helms Center as white papers and on websites.

Their work will also be presented in a variety of other formats (op-eds, blogs, policy briefs, books, etc.) to have maximum influence in the news media, on Capitol Hill and in academia.

Fellows will actively engage these audiences through regular interviews in print, radio and television; by providing Congressional testimony and offering their expertise as panelists at major think tank events; and through lectures and presentations at conferences and international gatherings. \*

# Meet Helms Center Friend Jay Stobbs



Retired Army Colonel E.E. "Jay" Stobbs is a committed patriot to his country and a tireless advocate for conservative principles. Jay spent his early life on the move. His father, a career Navy man, was stationed all over the United States. Jay was born in Evanston, Illi-

nois, raised in Corpus Christie, Texas and finished high school in San Diego, California.

After high school, Jay enrolled at San Diego State University and was a member of the Air Force ROTC. In 1965, with a presidential appointment, he transferred to the U.S. Military Academy at West Point. After graduation, he volunteered and finished both Ranger and Airborne school. Jay was assigned to the 588th Unit as a combat engineer and was scheduled to go to Vietnam.

Instead, his unit was diverted to Germany at the last minute. It was during his time in Germany that he met his future bride M.J. Hall. In July 1975, Jay and M.J. married in Durham, North Carolina. During his Army career, he taught at West Point and received master's degrees in physics and business administration. Jay spent his last years in the Army working in the Pentagon to remove nuclear weapons from the old Soviet Union and place them back in Russia.


Jay spent 30 years in the military and retired in 2000 as a Colonel in the United States Army. Today, Jay is an active member of many conservative organizations including the Jesse Helms Center and the North Carolina Committee for the Heritage Foundation.

# CHAMPIONS OF CAPITALISM

### Free Enterprise Leadership Challenge celebrates 15 years!

une was an exciting month for the Helms Center as we celebrated the 15th anniversary of our annual Free Enterprise Leadership Challenge (FELC). This year's program took place in two, five-day sessions on the campus of Wingate University. Almost 200 students from five states and four countries participated, helping to make this year one of the most successful programs to date. So what exactly did students do?



#### SUNDAY: DAY ONE

Students arrived and were given a crash course in basic free enterprise principles. The participants quickly learned they would have a week full of hands-on activities that would demand more than they expected! Within a few hours of their arrival they were off to work. Broken into small groups that we called companies, students elected company leaders and were immediately tasked with creating their business. By the end of the evening, all companies had a product or service, and they were already working on their business plans.

#### **MONDAY: DAY TWO**

Students participated in the Emerging Issues Debate first thing in the morning. It was a great exercise that got students thinking critically about threats to our freedom. By the end of the day

companies were actively engaged in their businesses - selling products and planning events.

#### **TUESDAY: DAY THREE**

Participants were working hard to complete their assigned tasks. A walking field trip to the Helms Center was a good break in their busy schedule. After a tour of the center and a screening of *Courage of His Convictions* (a short film about Senator Helms), students presented their company commercials.

#### WEDNESDAY: DAY FOUR

The speech contest was the highlight of the day. Students addressed the question: "Who is ultimately responsible for the BP oil spill, the government or the private sector?" Two students from each company effectively presented their answers to this challenging and complicated question in a series of five-minute speeches.

Students who attended the first session of FELC also participated in the annual E.A. Morris Banquet on Wednesday. Helms Center friends and supporters met and spoke with FELC participants while former N.C. Congressman and new Helms Center Board member Robin Hayes delivered the keynote address, sharing his thoughts on principled leader-

During the course of both weeks, students earned an impressive \$1,685 for the micro-finance website Kiva.org which supports budding entrepreneurs around the world.



## BB&T Lecture with Dr. Paul Bonicelli

Prior to his work with USAID, Bonicelli served as a professional staff member for the International Relations Committee (House of Representatives) and taught government and political science at Patrick Henry and Grove City Col-
